- I will be required to undertake a course of instruction appropriate to the duties of the patrol
- All service as a Citizen Volunteer is voluntary and no compensation of any kind is to be tendered.
- All equipment issued will remain the property of the Redlands Police Department and it must returned upon separation from the Volunteer Citizen Patrol.
- I will be governed by the Rules and Regulations of the Volunteer Citizen Patrol and the Redlands Police Department.

I understand that false or misleading information may be grounds for refusal or termination. I agree to provide the Redlands Police Department with all additional information that may be required to determine my suitability for membership with the Volunteer Citizen Patrol.
