- All equipment issued will remain the property of the Redlands Police Department and it must returned upon separation from the Volunteer Citizen Patrol Ranger.
- I will be governed by the Rules and Regulations of the Volunteer Citizen Patrol Ranger and the Redlands Police Department.

I understand that false or misleading information may be grounds for refusal or termination.
