For and in consideration of permitting the undersigned individual to participate in the City of Redlands' Triathlon program ("Program") the undersigned hereby voluntarily forever releases, discharges, waives and relinquishes any and all actions or causes of action for personal injury, property damage or wrongful death occurring to the undersigned which may arise out of the undersigned's participation in the Program, and any activities incidental thereto, for him/herself and for his/her, heirs, executors, administrators, and assigns. The undersigned further agrees that he/she shall not prosecute or present any claim for personal injury, property damage or wrongful death against the City of Redlands or any of its elected official, officers, agents or employees (Herein referred to as "Releasees" for any of such causes of action.

The undersigned acknowledges, understands and assumes the risks inherent in recreation activities, that such activities entail risks of physical injury to his/her person and property, and that the undersigned's participating in the Program with full knowledge of these risks. The undersigned further acknowledges and understand that this waiver includes, but is not limited to, any action or cause of action arising from (1) the City's performance of, or failure to perform, maintenance, inspection, supervision, control or security of the property on which the Program will occur; (2) for the City's failure to warn of dangerous conditions existing on or near the property on which the Program will occur; (3) for any acts or omissions by spectators; (4) for the City's supervision or selection of officials, players or coaches; or (5) for any hidden, latent or obvious defects or dangerous conditions existing on or near the property on which the Program will occur.

IT IS THE INTENTION OF THE UNDERSIGNED BY EXECUTING THIS INSTRUMENT TO EXEMPT AND RELIEVE RELEASEES FROM LIABILITY FOR PERSONAL INJURY, PROPERTY DAMAGE AND WRONGFUL DEATH CAUSED BY THE PASSIVE NEGLIGENCE OF THE RELEASEES.

The undersigned for him/herself, and his/herself heirs, executors, and administrators or assigns, agrees that in the event any claim for the undersigned's personal injury, property damage or wrongful death shall be prosecuted against Releasees, he/she shall indemnify and save harmless Releasees from any and all claims or causes of action by whomever or wherever made to presented for the undersigned's personal injury, property damage or wrongful death.

The undersigned acknowledges that he/she has fully read this Waiver, Release and Indemnity Agreement, has been fully and completely advised concerning the effects of the waiver, Release and Indemnity Agreement and is fully aware of the legal consequences of signing this document. The undersigned acknowledges that the City has no obligation to offer recreational leagues or to allow participant to participate in these leagues. Participant further acknowledges that the property upon which the activity is to be conducted may not be in a condition that participant agrees is safe, and it is up to the participant to inspect and make the determination whether in fact to participate in the recreational activity. By signing this form, participant is asking permission to participate in this program and acknowledges that he/she could be injured and that he/she is giving up legal rights. Participant is aware that participation in this activity is voluntary and that participation is voluntarily engaging in the activity with knowledge of the danger involved and hereby agree to accept any and all risks involved. Participant further acknowledges that he/she has the right to buy insurance offered through the Recreation Bureau to cover he/she for injuries arising from this recreational activity.

I have read and hereby agree to abide by the City's recreation Activity Rules. I further acknowledge that my participation in the City of Redlands' recreation activities will be jeopardized should I fail to adhere to those rules.
